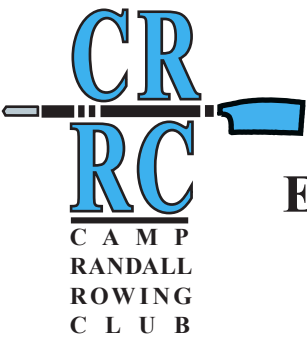

# Release of Liability



IN CONSIDERATION of being given the opportunity to participate in any USRowing activity, including scheduled, supervised club activities, and registered regattas, during the policy term 12/31/09 – 12/31/10, I, for myself, my personal representatives, assigns, heirs, and next of kin.

1. I ACKNOWLEDGE, agree and represent that I understand the nature of Rowing Activities, both on water and land based, and that I am qualified, in good health, and in proper physical condition to participate in such Activity.

2. I FULLY UNDERSTAND that: (a.) ROWING ACTIVITIES INVOLVE RISKS AND DANGERS of serious bodily injury, including permanent disability, paralysis and death ("Risks"); (b.) these Risks and dangers may be caused by my own actions, or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the Release named below; (c.) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation in the Activity.

3. I AGREE AND WARRANT that I will examine and inspect each Activity in which I take part as a member of USRowing and that, if I observe any condition which I consider to be unacceptably hazardous or dangerous, I will notify the proper authority in charge of the Activity and will refuse to take part in the Activity until the condition has been corrected to my satisfaction.

4. I HEREBY RELEASE, discharge, and covenant not to sue USRowing, the Club, the Regatta, their administrators, directors, agents, officers, volunteers and employees, other participating regatta organizers, any sponsors, advertisers, and if applicable, owners and lessors of premises, on which the Activity takes place, (each considered one of the Releasees herein) from all liability, claims, demands, losses or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Release or otherwise, including negligent rescue operations; and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement, I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS each of the Releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which any may incur as a result of such claim, to the fullest extent permitted by law.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.

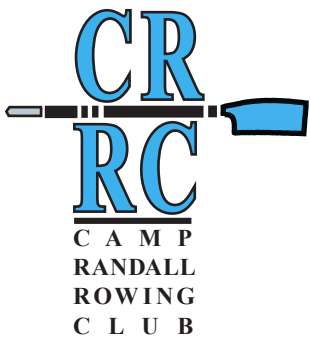

## JUNIOR CODE OF CONDUCT

CRRC aims to offer excellent rowing programs. The opportunity to participate is a privilege extended to all students. But with the right to participate comes the responsibility of managing one's behavior in a way that is appropriate for the program and that positively represents CRRC. For this reason, students and parent/guardians are asked to read and agree to the expectations of behavior and consequences for misbehavior below.

### **Student Behaviors:**

#### **DO :**

1. Follow directions of adult chaperone, team leader or coaches.
2. Respect the property and facilities being used.
3. Use words that encourage others.
4. Be prompt in arriving at your program.
5. Treat other students with respect.
6. Remain in your program for the complete time.
7. In competition, practice good sportsmanship.
8. Use equipment appropriately.
9. Have fun!

#### **DON'T:**

1. Refuse to cooperate or disrespectfully treat adult chaperone, team leader.
2. Vandalize or damage property.
3. Use inappropriate language (swearing) or volume.
4. Be late or inappropriate in the boathouse.
5. Be verbally and/or physically aggressive with others.
6. Leave programs without permission.
7. Taunt, harass or threaten others.
8. Endanger self or others.
9. Prevent others from having fun.

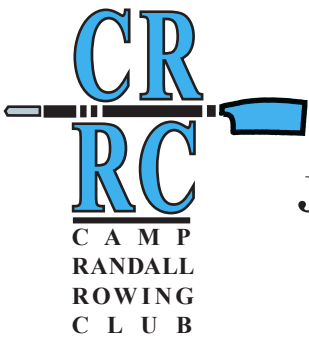
### **Consequences for Misbehavior:**

Depending on how serious the misbehavior is, students may need to miss part of a program activity, be suspended from the rowing program for a time period, or miss regattas or other crew activities. Adult chaperones and team leaders will report all discipline situations to the coaching staff. When students are suspended from rowing activities, they will need to agree to conditions before they are allowed to re-enter a program. When serious misbehaviors occur, students will be required to bring home a form for parent/guardians to review, sign and return as soon as possible. Failure to return the form will result in the student not being allowed to participate in their program.

CRRC wants its rowing programs to be fun places to learn important things. Students' positive attitudes, sense of fairness and respect, and desire to cooperate make a big difference in the quality of the activities.

## JUNIOR CODE OF CONDUCT- CONTINUED

### **Prologue:**

The Juniors involved in the development of the Code of Conduct elected to draft a Junior Honor Agreement. The purpose of the Junior Honor Agreement is to encourage junior rowers to responsibly participate in CRRC without the structure of an official Code of Conduct.

### **Agreement:**

As competitive rowers, we shall refrain from taking part in any activity that negatively affects the team, whether it is the use of tobacco, alcohol, illegal substances, absence from practice, a lack of effort or unsportsmanlike behavior toward a competitor, coach, or teammate.

Disrespectful conduct, as well as the use of tobacco, alcohol or illegal substances which impacts a rower's performance and relationship with the team will not be tolerated.

Rowing is a sport that requires much time and effort. Without consistent attendance and solid effort excellence in competition is unattainable. As intense competitors, we understand emotional outbursts, but disrespectful or unsportsmanlike behavior reflects poorly on the club.

**As junior rowers we recognize that there is no excuse for any of this behavior. We commit ourselves to follow the Standards of Behavioral Expectations for CRRC and as teammates we shall attempt to help those who have difficulty following this agreement.**
